Transportation Study Technical and Coordinating Committee Meeting

April 8th, 2025 Minutes

At 1:05pm, Dean Roberts opened the meeting.

Mr. Roberts noted that, per the Sunshine Act requirements, the meeting and agenda were advertised in the Scranton Times, Citizens Voice, and Hazleton Standard Speaker and the meeting time and agenda were posted on the LLTS MPO website more than 24 hours prior to the meeting.

1. Public Comment - Discussion of the items not listed on the agenda.

Mr. Roberts asked if there was anyone present who would like to make a comment. There were no comments.

2. Action Items

a. Approval of the January 14, 2025, Combined Technical and Coordinating **Committee Meeting Minutes**

Mr. Roberts asked for a motion from the Technical Committee to approve the meeting minutes from the January 14th MPO meeting. The motion was made by Susan Hazelton and seconded by Kate McMahon. The motion passed.

Robert Fiume asked for a motion from the Coordinating Committee to approve the meeting minutes from the January 14th MPO meeting. The motion was made by Tom Reilly and seconded by Mark Barry. The motion passed.

b. 2025 TIP and Actions

Amendments:

Steve Fisher and Mr. Roberts covered the amendments that would be made to the following TIP projects. MPMS 73300 - LLTS Highway Reserve revision, MPMS 121532 - Edwardsville Creekside Trail Connection, MPMS 111466 - Keystone College Ped & Trail Connections, MPMS 113623 - Hanover Industrial Estates MTM, MPMS 118849 - Rotary Drive Local Access, and MPMS 119725 – Sweet Valley Road Improvements.

Mr. Roberts asked for a motion from the Technical Committee to approve the amendments to the 2025 TIP. The motion was made by Mary Liz Donato and seconded by Barbara Idhaw. The motion passed.

Mr. Fiume asked for a motion from the Coordinating Committee to approve the amendments to the 2025 TIP. The motion was made by Rich Roman and seconded by Tom Reilly. The motion passed.

3. Discussion Items

a. Spring Project Commencement

- i. MPMS 116761 SR 347 over Kennedy Creek (Bridge Replacement)
- ii. MPMS 118738 T-718 over Roaring Brook (Bridge Restoration)
- iii. MPMS 119601 SR6 over Norfolk Southern RR(Bridge Preservation)
- iv. MPMS 115733 SR 1013 over Tobys Creek (Bridge Preservation)
- v. MPMS 121030 SR 2007 over RR (Bridge Preservation)

Eric Middleton presented the Spring Project Commencement for all projects in Lackawanna County, and Robert Manzella presented the Spring Project Commencement for all projects in Luzerne County. There were no further questions regarding the spring project commencement.

b. Gordon Ave Project Update

Ms. Idhaw provided a presentation update on the Gordon Ave project. The first phase of the project has been awarded for drainage improvement. The contract was awarded in the previous week while the agreement is in the process of being executed. This is scheduled to be completed in October. The paving portion of the project includes widening and utility adjustments. The bid package is currently being completed and will hopefully be ready for early 2026. Mr. Fisher asked if there is a cost estimate available for the paving portion of the project. Frank Summa stated that the estimate had not been complet3ed at this time, but it is on schedule to be within the \$1,000,000 K-route parameter. Mr. Fisher stated that an amendment should be made to add the construction phase of MPMS 121385 drawing down from reserve 70194, and 73359 for \$1,000,000.

Mr. Roberts asked for a motion from the Technical Committee to add an amendment for the construction phase of MPMS 121385 for \$1,000,000. Ms. Hazelton made the motion, seconded by Kathy Bednarek. The motion passed.

Mr. Fiume asked for a motion from the Coordinating Committee to add an amendment for the construction phase of MPMS 121385. Tim McGrath made the motion, seconded by Mark Barry. The motion passed.

c. Transit MOU draft Progress for the Federal Certification Review MOU

Dan Reese stated that the draft MOU was provided as it was added as a corrective action during the Federal Certification Review last year. Mr. Roberts stated that Tim Lidiak had reviewed the draft and stated that it was acceptable. The goal is to have the MOU completed by July.

d. Update for 2025 Planning Partners

Mr. Roberts stated that the Fall planning Partners would be held in late September, early October. Mr. Roberts stated that there were no further updates at this time.

e. 2025 TYP public outreach campaign for the 2027 12-year program

Mr. Reese stated that the STC is asking for feedback for the next TYP. On April 10th there will be an online forum to listen to as registration for the forum is requested. Mr. Reese stated that MPO staff would answer questions regarding the Forum or survey.

f. Safe Streets and Roads for All [SS4A] Progress updates

Ms. Donato stated that Lackawanna County had completed another steering committee meeting in February where 120 miles of roadway was identified as priority areas. The draft is set to be completed this summer and adopted this September.

Mr. Reese stated that Luzerne County selected Kittelson and associates as the consulting firm to help execute the Luzerne County Action Plan. Public outreach is currently being planned, and the steering committee is in the process of being formed. The kickoff meeting between Kittelson and Luzerne County has already taken place.

g. LLTS MPO website update (and social media)

Mr. Reese stated that the MPO has been having issues with the website. Blackout media has been contacted but the MPO will most likely need to reach out to new vendors to obtain proposals in order to update the media outlets for the MPO.

h. NEVI Community Charging Program MPO's NEVI fact sheet

Mr. Manzella stated that the NEVI program update included a new fact sheet that needs to be considered. The NEVI program survey for the region is created and allows residents to provide feedback on where they would be interested in seeing the program utilized.

i. The State Transportation Commission (STC) Survey ends April 30

Mr. Middleton stated that Mr. Reese had mentioned the survey earlier as it closes on April 30th. Mr. Middleton stated that the survey had been linked to the agenda that was sent to all meeting participants and encouraged them to share the survey with anyone who might be interested in providing feedback.

j. Long Range Transportation Plan Update

Brian Funkhouser provided an LRTP update that covered the finalization process for the draft product. The steering committee and MPO staff are currently helping to provide feedback on the draft as it is being finalized. Multiple public outreach sessions were held across the two-county region to garner feedback from the community. Michael Baker is continuing to break down comments and feedback currently. Michael Baker is also planning for the asset management process which will show how much and where the MPO will have the best impact regarding funding.

k. Funding/Grant Opportunities

Mr. Manzella spoke about the FAA Aviation Research Grants Program which closes on 9/7/2027 Research Grants Program encourages and supports innovative, advanced research of potential benefit to the long-term growth of civil aviation and commercial space transportation. Mostly for institutions of higher education. The Vehicle Technology Office Program Wide closes 6/18/2025 and supports innovation to reduce the energy and cost needed to move goods and people across the US. Examples include more convenient travel options, decreased cost of driving, increased vehicle and system efficiency. The Rural and Tribal Assistance Pilot Program closes on 4/17/2025. The RTA Program aims to help applicants develop transportation infrastructure projects in rural and tribal communities.

Progress Reports

a. PennDOT Connects Municipal Outreach Sessions – summary from this morning.

Mr. Fisher stated that PennDOT Connects was hosted at the district 4 office this morning. There was a series of listening sessions, bridge inventory was covered, and future outreach avenues were discussed. PennDOT will continue to do these outreach sessions across the state.

b. 2027 Tip Update Schedule

Mr. Roberts stated that the general procedural guidance and financial guidance are being released this spring, hopefully early May. There are no other major updates concerning the 2027 TIP schedule.
